Donnelly, actress appear in ad

Candidate for governor Tim Donnelly raised eyebrows last week with a new campaign video alongside actress and singer Maria Conchita Alonso.

In his three-minute "The People United" video, the Hesperia Republican and Alonso discuss his desire to cut regulation, reinvigorate the state's film industry and his opposition to the state's ban on lead ammunition, with Alonso sometimes translating, and at other times just paraphrasing, his views into Spanish.

The ad is tongue-in-cheek, with Donnelly proclaiming his wife

"I've been endorsed by (actor) Rob Schneider and had him at one of my campaign events, and I've made a lot of in-roads into Hollywood," Donnelly said Tuesday. "I became aware of Maria and we were looking to do an ad that would be different, something that would have some humor, maybe even start some healing. ... But most of all, we wanted something that would cut through the noise.³

Donnelly, who's represented the High Desert in the Assembly since 2010, is also the founder of a chapter of the Minuteman Project and a vocal opponent of illegal immigration.

"She's fiercely anti-Communist," Donnelly said. "We've all seen what the Communists have done to Cuba, we've all seen what they've done in Venezuela. And now she says, they're here in America."

But her appearance in a campaign video for Donnelly has already cost her a job: Last Friday, she bowed out of her starring role in a Spanish-language version of the "Vagina Monologues" next month, after the play was threatened with threats of boycotts and protests.

The pair don't actually see eyeto-eye on illegal immigration, he said. They also initially disagreed about hunting and animal cruelty, although he said they've both worked to educate the other on those issues.

Although the video has succeeded in the campaign's goal of getting attention, with coverage from the national media, including Fox News and Salon, Donnelly has no illusions that his campaign against probable incumbent candidate Gov. Jerry Brown is going to be any easier as a result.

"I'm in an uphill battle, I know what race I'm in, I'm not naive," he said. REDLANDS Grant awarded to continue equine therapy for vets

REDLANDS » Horses have an ability to strengthen mental health in a way that some traditional forms of therapy cannot, as Angie Sheer has witnessed over the years.

The team at Equus Medendi, founded by Sheer, has for the past three years provided equine-assisted learning and therapy to more than 100 military personnel and veterans at no cost through the San Bernardino County Department of Veterans Affairs, which recently secured a grant to help the non-profit continue its work at the Buffalo Meadows Ranch in Redlands

"This is just an alternative. It's a different approach. We're bringing them to a ranch rather than somebody's office," Sheer said.

The San Bernardino County Board of Supervisors approved the grant, allowing the department to help fund the seven-week program that helps ad-

Video attracting national attention

rancho cucamonga » A bullying incident at a local high school caught on video has captured national attention.

On Wednesday, Jan. 8, Etiwanda High School freshman Kobe Nelson and a classmate had a violent confrontation between classes. School officials intervened and, after interviewing students who had witnessed the incident, Nelson and his classmate were both suspended.

"After school, about 3:30 in the afternoon, I received a phone call from the principal at Kobe's school," Nelson's father, Tommy Purvis, said. "She made it sound like Kobe had been fighting back. ... I told her, if Kobe's been in a fight, and he had been

The video shed new light on the incident a week before, according to Chaffey Joint Union High School District Superintendent Mat Holton.

"This bullying incident occurred, it was fairly quick," Holton said Friday. "By the time (school officials) got there, it was over. They talked with both students that were involved. There were conflicting stories. ... They also talked with some other student witnesses and received some information that the threats were mutual - there were threats coming from both sides prior to the incident."

2 charged in Chino hammer attack on teen

CHINO » Prosecutors on Tuesday charged a Chino man and his wife in a hammer attack that critically injured a Chino High student.

The San Bernardino County District Attorney's Office said Gregory Undra Richmond, 48, caused great bodily injury to the victim, referred to in a complaint as John Doe.

Police said the victim, a 16-yearold boy, has regained consciousness since the attack.

"He is cooperating with the investigation and speaking with detectives," said Chino police spokeswoman Miunknown to each other. This was basically a verbal altercation that escalated to an attack."

The nature of the argument is under investigation.

The hammer that was allegedly used by Richmond has not been located, according to a Chino Hills press release.

Richmond's wife, Raina Renee Crawford, was also charged in the case with assault with a deadly weapon and helping Richmond escape arrest.

Police arrested Richmond and Crawford the day of the attack.

Police shut down Park Place between 10th Street and Benson Avenue to look for the suspect. Chino High and Walnut Elementary were both placed on lockdown while authorities searched for the person involved in the assault, according to a news release.

Richmond was arrested, within the hour, on the 5800 block of Riverside Drive without incident, the press release stated.

Richmond is in custody at West Valley Detention Center, in Rancho Cucamonga, in lieu of \$125,000 bail, according to the Sheriff's Department web site. Crawford is also being held at the same facility in lieu of \$50,000 bail.

"'Look Dad, I didn't do anything wrong: These kids were harassing me,'" Purvis said.

And video shot by a classmate with a cellphone surfaced, which corroborated Kobe's version of events.

This wasn't the first time Kobe and the other boy had clashed, Purvis said.

'In seventh grade, I saw this kid pick up an orange traffic cone and hit my son in the (crotch) with it," he said. "Apparently what happened is he saw his ex-girlfriend (post on Twitter) that she was hanging out with Kobe on winter break."

At first, though, the video which shows Kobe repeatedly attempting to walk away from the fight as he's pushed and finally pounced upon didn't make a difference, Purvis said.

"I go to see the administration on Friday. I have the video at this point," he said. "I went to show (the principal) the video and she shakes her head 'no' and raises her hand in the air, and says 'I don't need to see that; I know what happened."

So Purvis reached out to a friend of his, who runs the photojournalism blog Photography Is Not a Crime. Tuesday after the incident at Etiwanda High, the blog posted the video and a story, and things started happening in a hurry.

"Days later, this video appears and the school is able to look at the video and able to see there is clearly an aggressor and clearly a victim," Holton said. "At the beginning of this week, they rescinded (Kobe's) initial discipline."

And other students, shown instigating the fight on the video, "have also been identified and disciplined as well," he said.

Kobe's story also exploded on local television and on social media, leading to former NFL offensive tackle Kyle Turley reaching out to the freshman football player via Twitter:

"b strong Lil bro that #bully & the #badcop will b ask'n 4 ur autograph 1 day, believe me!" Turley tweeted.

Although the suspension was reversed, Purvis is keeping his son out of school as he objects to how a San Bernardino County Sheriff's Deputy - whom Purvis identifies as Luis Ortiz — handled the incident, including, according to a second video and post at Photography Is Not a Crime, mocking Kobe after he was suspended.

Purvis wants the deputy to be transferred to other duty, rather than being assigned to providing security at the district's high schools.

"I am not going to meet with anyone from the school or the school district until Deputy Ortiz is removed from all these campuses," he said. "I do not feel safe with
